AN ORDINANCE ACCEPTING TEMPORARY CONSTRUCTION EASEMENTS FROM VARIOUS PROPERTY OWNERS FOR THE SPRIGG STREET IMPROVEMENT PROJECT, IN THE CITY OF CAPE GIRARDEAU, MISSOURI

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CAPE GIRARDEAU, MISSOURI, AS FOLLOWS:

ARTICLE 1. The City of Cape Girardeau, Missouri, hereby accepts temporary construction easements from the following owners for the Sprigg Street Improvement Project, between William Street and Broadway, described as follows:
