All the grantor's land lying in a part of Lot 10, Thiele's Subdivision as recorded in Plat Book 4 at Page 51 of the land records of the County Recorder's Office, City and County of Cape Girardeau, State of Missouri, being more particularly described as follows:

The east 10.00 feet of Lot 10, and the south 10.00 feet of the east 30.00 feet containing 700 square feet more or less.

The above described parcel contains 700 sq. ft., more or less, of temporary easement for construction

Said right, privilege, permission and authority to enter in and upon said property above described is granted for the purpose of enabling the City, its agents, servants, and assigns to use said property to excavate, build, and construct certain land improvements for the North West End Blvd. Widening Project, in, on, upon, or across said described property, together with all the useful; necessary and proper adjuncts, appurtenances, and appliances in connection therewith, as shown on the plans and specification of file in the Office of the City Engineer. Said privilege is valid from the date this easement is accepted by the City Council through the date those improvements are accepted by the City Council.

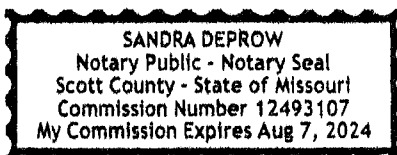

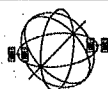
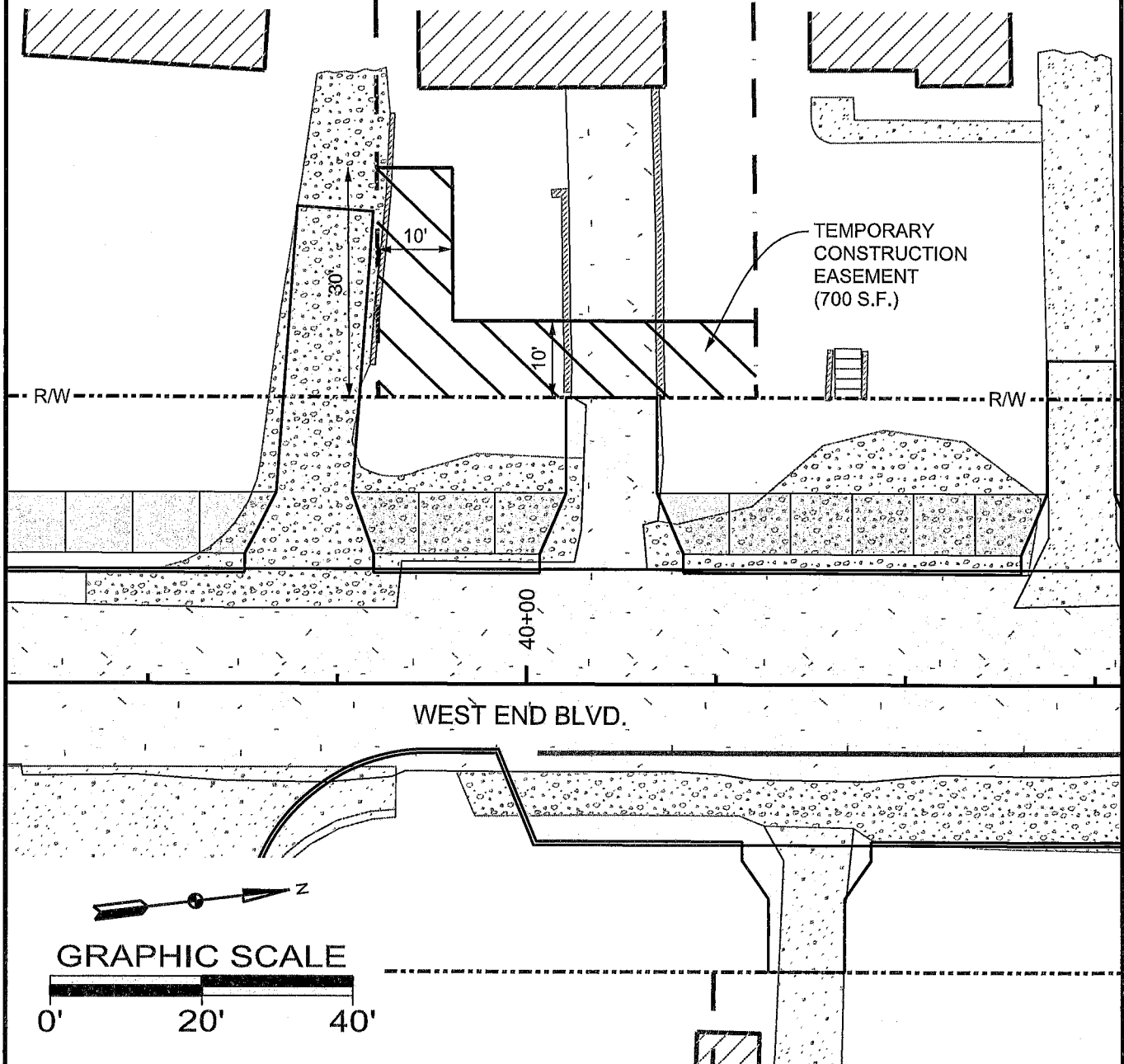
