At the time of closing, the City agrees to pay the sum of \$10,665 to the Owners of All that part of Lots 1, 2 and 3 of Block 1 of Brink's Second Subdivision as recorded in Plat Book 6 at Page 41 in the land recorders of Cape Girardeau County, being a part of Out Lot 55 in U.S. Survey 2199, Township 30 North, Range 14 East of the Fifth Principal Meridian, in the City and County of Cape Girardeau, Missouri; LESS AND EXCEPT, that part conveyed by General Warranty Deed to the Missouri Highway and Transportation Commission in Book 639 at Page 08 in the land records of Cape Girardeau County.

- 1. At the time of closing, the Owners shall execute and deliver a good Title Owner's Policy and sufficient general warranty deed conveying said land, with the hereditaments and appurtenances thereunto belonging, to the City in fee simple, free and clear from all liens and encumbrances.
- 2. The City of Cape Girardeau shall be responsible for paying ALL closing costs, good Title Owner's Policy and General Warranty Deed, including all Recording Fees.
- 3. The Owners represent that no elected City official or City employee shall be admitted to or share any part of this agreement, or to any benefits that may arise therefrom.
- 4. The terms and conditions aforesaid are to apply to and bind the heirs, executors, administrators, successors and assigns of the Owner.
- 5. All terms and conditions with respect to this agreement are expressly contained herein and the Owners agree that no representative or agent of the City has made any representation or promise with respect to this agreement not expressly contained within.
